Promotion Period:	March 29, 2004 through March 28, 2005	
Promotion Description:	Resellers who purchase eligible products from Sony and sell (ship ar invoice) the eligible products to end-users within the promotion period ar eligible to receive a rebate.	
	CLAIMS WILL BE TRACKED AGAINST PURCHASES. ANY CLAIMS THAT EXCEED PURCHASES WILL RESULT IN THE FORFEITURE OF THE REBATE.	
	REBATES WILL BE ISSUED WITHIN 30 DAYS OF RECEIPT OF INVOICE AND CLAIM IN THE FORM OF A CREDIT TO THE RESELLER'S ACCOUNT.	
	THE REBATE WILL BE EQUIVALENT TO 7% OF SONY'S CURRENT PUBLISHED DEALER ONE PRICE AT THE TIME OF THE CLAIM.	
	RESELLER MUST CLAIM IN ORDER TO RECEIVE CREDIT IN FY04.	
Eligible Models:	See model list on the previous page	
Sales to Rental Companies:	Sales to rental companies are not eligible. Sales/purchases from reseller to reseller are not eligible. Sony reserves the right to reject claims regarding sales that it deems are sales other than to end users	
Mixing of Promotions:	This program can be combined with other programs outlined in this bulletin. Separate rebates will be issued to your account.	
Inventory:	Product class is specific to Model/Category. Inventory purchased prior to March 29, 2004 does not qualify.	
Product Substitution:	There are no product substitutions available.	
Quantity:	The Reseller may make only one claim per unit sold.	
Returns:	In the event an eligible product is returned to Sony, Sony reserves the right to issue corresponding debit memos to the Resellers. Returns will be monitored.	
Audit:	Sony reserves the right to request POS reports from Resellers on a quarterly basis to audit the data provided to the Manage Your Money website.	
Claim Process:	A Key Model Sell Thru Rebate Program claim form must be submitted on-line by providing eligible product model name, serial number, date of sale, end user customer invoice number, and customer name. Note* The Rebate will be equivalent to 7% of Sony's current PUBLISHED dealer one price at the time of the claim.	
	 The MANAGE YOUR MONEY claim procedure is a four step process: The Reseller should go to www.sony.com/manageyourmoney The Reseller should select which promotion they are submitting the claim for. The Reseller should enter their claim on-line at MANAGE YOUR MONEY Rewards HQ. The Reseller should go to the promotion website; select the program for which they want to process a claim; complete the on-line claim form (the Reseller's sales invoice number to the end user must be included) and hit the "Submit" button to process the claim. The processed claim should now have a claim number The Reseller should print out a copy of the completed claim form and keep for their records.

TERMS AND CONDITIONS (Continued):

Submission Deadlines:	All claims must be submitted by the Reseller on-line at		
	www.sony.com/manageyourmoney within 60 days after the month of the		
	claim.		
Claim Dispute:	Any claims that are denied that the Reseller want to dispute must be		
	resolved no later than 60 days beyond the submission deadline. To dispute		
	a claim, the Reseller should call the toll free number provided on the		
	website of 1-800-462-7377. In the event of any questions or		
	interpretation of the terms and conditions of this program, the decision of		
	Sony will be final. Sony has the right to audit any Reseller invoices that are		
	submitted for this program.		
Claim Payment:	The payment will be in the form of a credit to the reseller's account.		
	Please allow 45-60 days for payment from the date that the claim was		
Dl	entered.		
Bankruptcy:	Credits, discounts, rewards and rebates issued to the Reseller under this		
	program are available for use by the Reseller only for the future purchase		
	of products from Sony, are not cash equivalents, do not create a right of payment to the Reseller, and are not deemed earned until products		
	purchased with them are paid for in full. Any such credits, discounts,		
	rewards and rebates are subject to all of Sony's rights under applicable		
	state or federal law, including, but not limited to, its rights of setoff and		
	recoupment. If the Reseller is the subject of a voluntary or involuntary		
	bankruptcy proceeding, the automatic stay will not be applicable to any		
	attempt by Sony to effect a reconciliation of accounts with the Reseller by		
	applying any such credits, discounts, rewards and rebates due to the		
	Reseller against amounts due to Sony.		
	If any merchandise or amounts previously paid by Reseller to Sony are		
	returned, forfeited, or subject to avoidance or similar action in a		
	bankruptcy proceeding or a proceeding under any similar state or federal		
	law, such credits, discounts, rewards and rebates will be deemed null and		
	void and not earned, and any credits, discounts and rebates previously		
	issued to the Reseller that, for whatever reason, are not deemed null and		
	void, will be used to offset any amounts due Sony.		
Change/Cancellation:	Sony may change or cancel this promotion at any time.
